### Section 4 - First Aid Measures

<b>Inhalation</b>	:	If Sodium Butyrate is inhaled, remove to fresh air. If breathing is difficult, give oxygen. Get medical attention.
<b>Ingestion</b>	:	Give large amounts of water to drink. Never give anything by mouth to an unconscious person. Get medical attention.
<b>Skin Contact:</b>	:	In case of contact, immediately flush skin with plenty of water. Cover the irritated skin with an emollient. Remove contaminated clothing and shoes. Cold water maybe used. Wash clothing & Shoes before reuse. Get medical attention.
<b>Eye Contact</b>	:	Check for and remove any contact lenses. In case of contact, immediately flush eyes with plenty of water for at least 15 minutes. Cold water may be used. Get medical attention.
